

Hi Erica.

Thanks very much for your congratulations! And apologies on my end with the reporting process. This is my first time submitting an NSF report on my own and I should have been in touch earlier to make sure I had everything in order. I have a few questions below, if you've got the time.

First, and perhaps most importantly, my data is sensitive as it mostly contains Indigenous knowledge of subsistence resources, activities, organizing, and ongoing work and research that isn't public or published. My IRB with the included protections against publishing the data in public repositories, and I do believe that is reflected in my data management plan. I believe it is also supported in the documentation I have published with my dissertation. Can you advise if and how I can best go about receiving a more formal exemption for publishing my data? I can certainly include the DOIs of derived products (dissertation and possibly CAFF report (see below)) to the Arctic Data Center.

Second, my CAFF publication was formally published, but it had been expedited and actually published December 2019, just before the grant period was set to begin (I remember we had some delay in my grant review). I still consider it an important product of this grant, and I was able to spend additional time during this grant with that particular data for the manuscripts coming from my dissertation. I would like to include the CAFF publication as a grant product, but please advise if this is acceptable given the early publication date.

Third, my three manuscripts are currently in review and not yet published, so I don't believe that I can include them as products at this time. Are these products I can include later? I can certainly link to the Wilson Quarterly piece and the other public-facing pieces I included in the final report.

Fourth, I'm actually on leave at the moment, and am fly and out of service until Tuesday. What should I do about the report deadline tomorrow? I wouldn't want my old PI to be alarmed with any overdue messages. Is this something I can take a few days on or do you need it ASAP?

I'm so glad you found our meeting helpful. As long as your fellowship topic addresses EAR science questions, the EAR program would consider your fellowship proposal. But the best way to check is to draft a one-page summary (like the first page of your proposal) that you think fits the EAR program description, and send it to Aisha Morris at armorris@nsf.gov

I'd definitely recommend that tailor your proposal to EAR--in other words, go through and make sure that your proposal hits EAR priorities, rather than emphasizing the Arctic context, which is what OPP is after.

Ask Aisha for her feedback, and simply indicate that you applied to the OPP PRF, but you think the project may be a good fit for EAR. Aisha should be able to give you a good 'read' on whether your project would be competitive in EAR.

And, if you're still eligible for the OPP PRF in February 2023, you could apply again to OPP. It's fine to submit to both PRF programs, as long as you inform the program officers that you have a simultaneous submission and declare it on the Current and Pending document required with submission. Again, don't submit the exact same word-for-word proposal to both programs--tailor each to the priorities of EAR versus OPP.





Re: Logistics: general rule of thumb is to plan one year ahead, so no, I do not expect you would be able to get logistics support for summer 2023 with a fall/winter 2022 proposal submission. It is unlikely we will have a final decision for you by January 2023. A quick external review takes a

Sharing it with the NSTC subgroups on co-production/co-stewardship and research not only because it is led by an Indigenous scholar, but because I feel it also is an example that includes Indigenous knowledge holders in the lit cited. And instead of citing traditional arctic science academics only and perpetuating those sources as *the* credible sources, it includes IK holders and Indigenous sources as the primary sources. I've seen some social equity and justice themed journal articles recently that I was kind of surprised they

included many/mostly academic and non-Indigenous scholarship. An important part of centering IK is also recognizing and valuing primary sources and the Indigenous scholars (like Kaare) who occupy this difficult/tricky space.
